

Charge Handover by the New EC

The newly elected Office bearers were handed over the charge by the outgoing EC on 1st June, 2018 in a meeting held at the Department of Sociology, University of Rajasthan, Jaipur. Dr. **Mahesh Nawria** was re-nominated by the president to continue as the treasurer of the association and due gratitude was appropriately accorded to the outgoing office bearers, EC and the returning officer for EC Election 2018.

First EC Meeting

The First Meeting of the newly constituted EC was held on 01/06/2018 after the charge take over by the new EC. Nine members namely, Prof. S C Rajora, Dr. Ashutosh Vyas, Dr. Meenakshi Meena, Dr. Deepa Mathur, Dr. Ruchika Sharma, Mr. Tribhu Nath Dubey, Dr. Mahesh Nawria, Mrs. Supriya Seth and Dr. Sharmila Kumari were present in the meeting. Three members, Dr. Lalit Kumawat, Dr. Paresh Dwivedi, and Dr. Manee Ram Meena were granted the leave of absence by the chair. The meeting began with the appreciation of team work of the previous EC and diligent work done by the returning officer Prof. Sushma Sood.

The EC appreciated and highlighted the work being done by the present editorial team and reposed its full confidence in them to continue their work. It was heartening to know that the editorial team under the inspiring leadership of Dr. Naresh K Bhargava is working towards bringing out **the decadal issue of the Journal**.

I was felt that RSA will have to take various measures of fund raising to undertake the ambitious work plan. It was also felt that present life membership fee should be revised with due permission of the general body of the association to make it commensurate with the current circumstances.

The current state of affairs and future plan of action for the association were also discussed in the meeting. The president and the secretary shared the possible deliverables with the members and requested them to deliberate upon these issues so that actionable road map for RSA is prepared collectively.

Organizational Deliverables under Consideration

- 1. Annual Budget and Action Plan Exercise.
- 2. Discussion on Golden Jubilee year Celebration of RSA.
- 3. More involved Editorial advisory Committee, Blind fold referral and UGC empanelment of RSA Journal.
- 4. Constitution of RSA Newsletter Editorial board and publication of E-newsletters only.
- 5. Regional **Young Writers** & **Young Researchers** Workshops: Modules, Resource persons, frequency, hosts, duration and outcome etc. Possibility of collaboration with research directorate of universities for research workshops through liaisoning with respective VCs.
- 6. RSA registration under IT Act 80 G
- 7. Self-Sustenance strategy for RSA: 1. Augment life membership, 2. Nominal sharing of conference Registration with host organization & 3. Individual donations and sponsorships.
- 8. Action for allotment of subsidized land for the organization in any of the divisional headquarters.
- 9. Association with ISA
- 10. Annual conferences, seminars, workshops: invitation of Proposals for the annual conference, seminars, workshops. Incentivization and promotion of quality participation in RSA conferences.
- 11. Correspondence with UGC, ICSSR, Ministry of welfare/Culture/ASI for the grant. A committee of two three members may be constituted for this purpose so that possibilities could be explored.
- 12. Revamp of RSA Website.
- 13. Content analysis of RAS and Civil Services Examination Syllabus in view of alleged ignorance of sociological content in the respective syllabi. Explore & adopt suitable strategies to reach out to the concerned authorities and adopt available persuasive strategies.
- 14. Lobbying and persuasion for the expansion of the teaching of Sociology at higher secondary level in the state. Department of Higher Education and School Education to be approached to explore the possibilities to open Sociology as a subject in more colleges and schools. Letters to VCs may be sent to open Department of Sociology in their University.
- 15. Projects for sociological study of Rajasthan. Region wise proposals can be prepared by the young scholars with the help of senior consultants preferably retired persons. Working teachers may be requested to get involved as principal investigators. Funding agencies are to be explored.
- 16. A revisit plan for the significant places studied long back by the eminent sociologists in Rajasthan.

Report of the 24th RSA Annual Conference



The XXIV National Conference of RSA was on "Sanitation, Health and Urban Development" on 21-22 December, 2017. It was jointly hosted by Department of Sociology & Centre for the Study of Social Exclusion and Inclusive Policy of University of Rajasthan. The organizing secretary of the conference was Dr. Rashmi Jain. The Key Note address was delivered by Dr. Bindeshwar Pathak of Sulabh International who eloquently deliberated upon the relation between sociology and sanitation and stressed upon increased engagement of sociology in the field of sanitation for bringing about much needed social changes related to caste prejudices and lingering social stigma. Approximately 150 research papers were read and discussed over the two days of the conference which were spread over 10 technical sessions. The deliberations covered contemporary issues and challenges of our times such as 'Relevance of Sociology of Sanitation', 'Health', 'Cultural Practices of Health', 'Government Initiatives and quality of Life', 'Challenges of Urbanization', 'Urban Poverty',

'Urban Change and Development', 'Smart Cities', 'Civil Society intervention for sanitation' and 'Urban inequality, Law and Social Change'. The valedictory remarks were given by an eminent social scientist Prof. B K Nagla with the Honorable Vice Chancellor of University of Rajasthan, Prof. R K Kothari as the chair of the session. A wide participation from various states of India and members of RSA seemed amply satisfied and motivated with the intense deliberation and relished the hospitality of the host organization.


The first memorial oration; in the fond memory of ex-president of RSA and Indian sociological Society Late Prof. Ishwar Modi, instituted in association with RSA by his loving family; was delivered by Prof. Pratap Bhanu Mehta – a distinguished social scientist and Vice Chancellor of Ashoka University on 21st December, 2017 after the inaugural session of RSA annual conference in the Humanities Hall of University of Rajasthan before a jam-packed gathering of RSA delegates and dignitaries from the city of Jaipur. His poignant and eloquent exposition was on "Sociology in Times of Crisis" and taking cues from the social circumstances of the pioneers of Sociology he advocated that best of the sociology comes in the worst of the times. Juxtaposing it with the social situations and recurrent unhappy socio-political events, he stressed that it provides a critical opportunity for doing a significant sociology by all of
